Public hearing opened at 7:05 p.m. Mr. Zaremba stated all requirements were met and thus the public hearing may proceed. Mr. Lagastee stated why he wanted to store his semi truck at his new home. President requested comments from proponents to the request. Mrs. Sessa, realtor that sold house, spoke in favor of the petition. There were no other proponents. The President requested comments from opponents. There were none.

Staff report. Mr. Mandon stated that the petitioner does not meet all five conditions required by state statute for the granting of a use variance. He recommends the BZA deny the petition.
