Ms. Bruckheimer made a motion to allow Mandon and Frost to ask the Town Council for paperwork submission to be handled by the town.

2. Mr. Babcock, Georgei, ad Brennan asked the council for a 1 (one) year extension on the Iron Triangle single family PUD. Explained that the housing market fell this quarter and new lending requirements are not helping their current efforts. Kremke questioned, PUD: No extension needed, subdivision ordinance is good for one year, correct?
PUD is regardless, Plat approval could continue. Extensions can carry over as long as no changes other than ownership occur. (54 lots).
Bell stated that 2<sup>nd</sup> extension to be the Final extension. No more extensions will be allowed. This will be the final extension to carry through June 2013.
Ms. Bruckheimer made a motion to allow the final extension and allow it to

carry over if the property comes into new ownership.
