Mr. Mandon it is true that methane gas is colorless and odorless the elements that go along with it are not. The issue here is primarily the animals and it is the number and the amount of setback from property lines.

Mr. Eriksson states he thinks it is a good thing he has a problem with the animals. He wouldn't have a problem if it wasn't for the animals.

Ms. Frost states that the zoning ordinance takes precedence with the animals. With the rezoning request you make a recommendation to the town council. The Indiana statue allow you as rezone request you can have a written commitment to put limitations on the animals. You would have to do a written commitment to make it binding.

Mr. Wagner made a motion to send a favorable recommendation to Town Council without exceeding the number of animals listed.

Mr. Wagner would like to withdraw his motion.

Ms. Brueckheimer mad a motion to send a favorable recommendation to Town Council with the following exemption on the limited number of animals 2 cows, 4 beef cattle, up to 20 rabbits, up to 30 chicken, up to 10 turkeys, and 2 goats.

Mr. Timm seconded the motion.

Ms. Brueckheimer is amending her motion to add a 100-yard setback for the animals.

Mr. Timm seconded amendment

Brueckheimer, Timm, Duffie all voted yes. Wagner and Eriksson voted no.

Motion failed.

Mr. Wagner made a motion to send an unfavorable recommendation to the Town Council. Mr. Eriksson seconded the motion.

Brueckheimer, Timm, Duffie all voted no. Wagner and Eriksson voted yes. Motion failed.

Mr. Timm made a motion to table until next meeting. Ms. Duffie seconded motion. Motion passed 5-0
