K. Public Hearing

Public Hearing commenced at 7:17PM. Bill Davies of Davies surveying appeared on behalf of Anthony and Rosalie Gardner requesting a re-plat of1140 Cardinal Ct. Attorney Sobkowski reviewed the notice and determined that notice to all required parties had been issued. Petitioners Anthony and Rosalie Gardner originally had four lots in an unrecorded subdivision, said their representative Bill Davies of Davies Surveying. He asserted that the new parcel created conforms to the requirements of the Porter zoning ordinance.

Town planner Jim Mandon said specifics of any proposed development on the site, which is zoned residential, would have to be laid out for review at the time a building permit is sought. A separate driveway will serve the new parcel, and no additional public utilities have to be installed. Because the Gardners' request is considered a minor subdivision, both primary and secondary plat approval were to be considered. Nobody came to speak in favor or opposed. Public Hearing closed at 7:18 p.m.

Nelson asked if they would be sharing a driveway. Spanier there would be two separate drives. Bruckheimer concurred stating they would be installing a new drive. Nelson inquired with Counsel as to whether the findings of fact as presented met all the requirements. Attorney Sobkowski confirmed technical requirements were met.

Nelson made a motion to approve the Petitioners request for a replat of 1140 Cardinal. Wagner Seconded.
