#### Reports

Director of Development Mike Barry announced he has reviewed two changes orders for the Brickyard Trail. Change order #20 involves utilizing a portion of an existing trail that would result in a price reduction of \$26,961.05. Change order #21 addresses unsuitable soils that were not anticipated per the original design borings, resulting in a price increase in the amount of \$24,668.30.

Barry stated the original construction cost of the Brickyard Trail was \$2,997,881.71 and right now including these changes orders we are \$87,000 above the initial cost.

Motion to approve the Brickyard Trail change order numbers 20 & 21 as submitted was made by Greg Stinson. Jeannine Virtue made the second.

Barry stated the title work, appraisals and acquisition list have been received for the Munson Ditch properties.
