Rex Construction. \$114,900.00

All three bidders had all required documents and Ryan Construction included winter materials in their bid price. He stated the Commission could award bid or hold off until spring and re-advertise for bids. Mr. Babcock made the motion to accept the lowest bid and award contract to Ryan Construction. Mr. Fowler made the second.

The Commission questioned waiting until the spring to start project. Concerns the winter road salt would damage the new concrete.

After discussion, Mr. Fowler retracted his second to the motion and Mr. Babcock withdrew his original motion.

Commission requested Mr. Kieser contact Ryan Construction to ask to hold price of bid until mid April or submit change order.

Bid Awarding tabled until next meeting.

Mr. Theide announced he has received a route change request to the Orchard Pedestrian Way, made by the Porter Park Board. (See Attached)

The Board has concerns of the placement of the new sidewalk stating it would interfere with gazebo rentals. They are requesting the sidewalk be kept along roadway. Mr. Theide stated the change would not delay any construction, but need plans to go back to surveyor.

Mr. Raffin made the motion to approve change as requested. Mr. Babcock made the second. Motion carried 5-0.
