Old Business:

Porter Brickyard Trail.

Matt Kaiser of the Duneland group presented information from the Norfolk Southern meeting that was held. Norfolk Southern will not accept a tunnel and wants a bridge instead. Matt presented a new trail estimate of \$3,386,284.37. The town's share would be \$742,248.37. Matt is going to apply for more TE money for this project. See his attached breakdown.

Beam Street sewer project was discussed. Only one bid from HRP was received. At the suggestion of the Town engineer the bid was rejected. Paul Childress moved to reject the bid and Al Raffin seconded. Motion passed 4-0.

Orchard Pedestrian Way.

Shem of Haas and Associates presented a new cost estimate based on the Park Departments request to route the trail thru the park. See attached. Town share would be \$797,624.50. The Park Department's request has added \$300,000 to the cost. This will be looked into further.

Cleaning of Downtown sewers. Only some of the sewers have been completed. The contract needs \$32,000 more to complete all the downtown sewers. See map of sewers completed to date. Paul Childress moved to allow the contractor to continue not to exceed an additional \$32,000. Al Raffin seconded. Motion passed 4-0

Louis Craig Chief of the Porter Fire Department wants money for a new rescue truck. This request was put on hold pending the final numbers from the money request above.
