Duneland Group will try to get an approval from the Federal Highway Department to build the trail in 2 phases while the final connection from Yost School to the Prairie Duneland trail is worked out. It was announced that Indian Ave. is the currently approved route, however, we are studying alternatives. 4 other routes are being studied. More discussion ensued with Indiana Ave residents voicing their opposition to the current route.
