Bugajski said the cost is \$3,000.00-\$4,000.00 and is asking the RDC to pay for 3/4 of the cost while the Park Department will pay the remaining 1/4.

By consensus, Bugajski was authorized to solicit quotes and report back at the next meeting.

New Business

MCR Presentation

MCR Consultant Matt Reardon stated they were working on two main projects. One being the Brickyard Property; noting that there has been some interest in the development of this site for multifamily uses, as was put forth in the Downtown Master Plan.

The plan suggested a zoning change to accommodate multi-family use when, at the time, were considering what to do with this property. And asking what would be the best course of action for the community.

The Downtown Master Plan was part of Lake Michigan Costal Grant and went along in concept with the RDA Grants.

With said interest in the property Reardon has drafted a request for qualifications for our Attorney's review. The start of this process would be to authorize MCR to seek two appraisals for this property in order to reach a number to put in the newspaper seeking input from Developers wanting to invest money in the Town. Once appraisals are in will take an average of both; finalize the requests for qualifications and place an ad in the newspaper. The original purchase price for this piece of property paid by RDC was \$350,000.00.

After a brief discussion on appraisal options, Jeannine Virtue made the motion for MCR to obtain two appraisals; with the selection of those appraisers to be made by Elka Nelson, Erik Wagner, and Mike Barry. Brian Finley made the second.

Motion carried, 5-0.

The next, or second main project has to do with the 49 Gateway/20 & 49 area. With a change of plans by the property owner the Lake Erie Land is no longer available for development. In spite of these challenges, there is still outside interest in property along 20 more specifically south of 20 and east of Tremont Road. These parcels are owned by the Town of Porter, Town of Chesterton, and Porter County and have the potential of a very large industrial avenue.

It would have to be a combined voluntary annexation of all three communities; however Porter would be the first phase as that the majority of the traffic would be coming through us.

The goal is to get Porter's parcels (approximately 60 acres) ready for development, perhaps with the help of RDA monies. A meeting has already taken place with Town of Chesterton officials and discussions are still continuing, if plans go through this will be a very significate project for all communities.
