TIF Bond Update – Umbaugh Consultant Matt Eckerle announced in response to the RFP's we received two proposals. Request to serve as placement agents were Fifth Third Securities and City Securities. Eckerle also gave the Commission (herewith in attached) a packet that included a preliminary finance analysis prepared by Umbaugh and the two proposals for placement.

Eckerle said the next step is the adoption of the Bond Resolution and recommended perhaps the RDC calling a special meeting on May 12th, the same night as Town Council Meeting allowing both boards to adopt the Bond Resolutions. The RDC Resolution will be written to allow the allocation to be decided at a later time.
