## **Business Improvement Grant**

Mike Barry stated the amount for the Grant has yet to be determined.

David Phillips said the RDC should decide the amount prior to figuring what the criteria is to meet that Grant.

Allison Hultman asked what amount the Budget allow. And feels that the Grant should be exterior focused only.

Barry noted that a few Porter Business did apply and receive Grants through the DEDC Façade Grant Program, however they had problems finding people to apply. They did at one point change the name from Façade Grant to Improvement Grant but eventually ended the program.

Barry has different versions of Grant Programs from other entities and said we just need to narrow down and determine what details we want, such as exterior driven or what scope of project.

He also noted that the Grants would be matching, and he could facilitate the Grant since he would be the one issuing the Building Permits for the projects.

Stinson said being newly appointed back to the RDC, he has not reviewed the RDC budget. And before he could vote for or against he would need to see how much of that budget would support such a project.

Barry said he will resend all documents and information he has and members can send comments or questions back and perhaps have something together for the next meeting.

# **TIF Capture Determination**

Hultman stated that the Redevelopment Commission has determined that there is no excess assessed value that may be allocated to the overlapping taxing units.

She asked for a motion to capture 100% assessed value for 2023.

Greg Stinson made the motion for the RDC to capture 100% of the eligible incremental assessed value for 2023. David Phillips made the second.
