PW Superintendent Spanier stated he put out requests for quotes for concrete for the Lincoln St project. Kenny's Concrete, Cabe's Concrete, and American concrete. Cabe's came in at \$24,300 and if he uses Davis concrete for leveling it would be at 23,550. There was no response from Kenny's Concrete and American Concrete was the local responsible quote of \$19,300. Spanier would like the RDC to accept that quote. PW superintendent Spanier has a question, the poles will not be in until mid to late November. American Concrete said that they could do the work but it will cost more money and there could be flaws. The solution is to have Circle R do the work early before they get the poles so that we can do the concrete before winter, and when the poles come in they can put them up. Spanier comments the only problem with that is it will be dark a couple of months. The only other alternative is wait until next spring.

Brian Finley asks does Chief Allen have any problems with being dark a couple of months. Spanier says he might he hasn't asked.

Allison Hultman asks what about a safety standpoint? Spanier said he is good either way.

Don Craft asks if quotes still good until spring.

PW Superintendent Spanier states he will contact the concrete company and see if prices are good through the spring. Circle R has already said they were good with the spring.

Russ Erwin made a motion to table the sidewalk project until next meeting, with Allison Hultman making second.

Motion carried 4-0.

Allison Hultman asks what does by others mean on the quote, Spanier states that means the Town will do it to save on cost.
